The undersigned understands that the Rappahannock Regional Solid Waste Management Board (R-Board) is providing \_\_\_\_\_ (HOA) a 40-cubic yard container as part of the Community Pride Program for a **partially refundable deposit of \$450.00**. Monies in excess of the tipping fee of \$43.00 per ton will be refunded upon weighing the dumpster. Should the dumpster weigh more than eleven (11) tons, no refund will be provided. In addition, the R-Board reserves the right to withhold a rate of \$32 per hour for our driver to prepare the box for loading if any debris prevents the door from closing or if any material protrudes higher than the tarping mechanism will cover. Per policy and regulation, the R-Board cannot load and drive the truck with the dumpster before securing all doors and tarps.

The deposit must be received at the same time as this Dumpster Request form. Checks may be made payable to "Stafford County Treasurer". There is a \$35 fee for all returned checks. Please remit deposit and this completed Dumpster Request form to the R-Board Administrative Office, PO Box 339, Stafford, VA 22555-339 or deliver in person to the R-Board Administrative Office, 1739 Jeff Davis Highway, Stafford, 22554 between the hours of 8am-4:30pm Monday through Friday. Upon receipt of payment, the R-Board will notify the contact listed above to confirm the preferred date.

The undersigned HOA will be *responsible for the management* of the container while it is at the above location. No tires, hazardous chemicals, pesticides, paint, petroleum, household waste or commercial contractor debris, etc. will be disposed of in this container. **The undersigned HOA will be responsible for any trash accumulation outside of the R-Board container before, during and after the container has been removed from the site. Once the container is full, the door must be closed. The debris must not protrude beyond the top of the container. Waste and debris overflowing from the container will be left by the R-Board and responsibility for disposal of those items will fall to the HOA.** By signing this application, the R-Board, Stafford County and its employees, officers, and agents will not be liable for any damages to HOA property, which may result from such placing of containers being provided by the landfill staff.
