



LANDFILL USER FEE INFORMATION

Residential Disposal Rates

- \$120 Annual Passes
 - Unlimited use
 - Valid January 2 - December 31
 - Vehicle Registration is required
 - Annual passes must be affixed to your vehicle or entry to the Landfill/Convenience Center will be refused.
- \$40 Coupon Books (10 Coupons)
 - No expiration date
 - 1 coupon per visit
- \$20 Residential Oversize Load fee
 - Any material waste transported by a cargo vehicle or trailer more than eight feet in length
 - Vehicles rated more than one ton are considered Oversize regardless of material
 - All material **MUST** be contained within the containers
 - Cargo vehicles or Trailers over 8 feet in length can be used to bring up to 4 trash bins of 100 gallons or less each and not be charged the Residential Oversized Load Fee
- \$5 Per Visit – Only available at the Regional Landfill

Cargo Vehicle - open or enclosed cargo space and cargo vans with only driver and front passenger seating. This definition extends to dump trucks, box trucks, moving vans, and enclosed trailers. Any vehicle over 1 ton in rated vehicle size will be considered Commercial.

Recycling remains **FREE**

The following rules apply:

- Cargo Vehicles are subject to a \$20 fee that an annual pass/coupon book will not cover
- You may use a Cargo Vehicle **ONLY** if the waste being transported is placed in up to 4 trash bins of 100 gallons or less and is completely secured and contained within the bins
- No refunds will be provided
- Stickers must remain permanently affixed to the correct vehicle
- Annual passes/coupon books may not be used for dispose of commercial/business waste including but not limited to: Yard waste, Construction material, Demolition Material, or Office supplies
- Any annual pass may be revoked if false information is provided
